

RESOLUTION NO. 2136-07

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF WINDSOR
ADOPTING FEES FOR ANIMAL CONTROL SERVICES**

WHEREAS, the Town Council for the Town of Windsor has adopted the Town of Windsor Animal Regulations Ordinance, codified as Chapter 4 of Title III of the Code of the Town of Windsor; and

WHEREAS, Title III, Chapter 4, Article 1, Section 115 authorizes the Town Council to establish a schedule of fees and charges for services provided by the County of Sonoma under the Animal Regulations Ordinance; and

WHEREAS, pursuant to Title III, Chapter 4, Article 1, Section 115 the fees and charges established may recover the reasonable cost of providing such services and issuing such licenses; and

WHEREAS, these fees were established by Resolution No. 111-92 on December 9, 1992, revised by Resolution No. 734-98 on June 17, 1998, revised by Resolution No. 1016-01 on April 11, 2001, revised by Resolution No. 1750-05 on April 20, 2005, and further revised by Resolution No. 2012-07 on October 17, 2006 at the same rates charged within the unincorporated area for similar services provided by the County of Sonoma; and

WHEREAS, the fee increases are due to higher labor and operational costs.

NOW, THEREFORE, BE IT RESOLVED that the fees for animal control and field services within the Town of Windsor shall be as follows:



BE IT FURTHER RESOLVED that the Town Manager has the authority to modify and/or waive fees based on good cause and in the interest of justice.


