

ORDINANCE NO. 2011-270

**AN ORDINANCE OF THE TOWN OF WINDSOR
AMENDING TITLE IV ARTICLE 7 OF THE
MUNICIPAL CODE OF THE TOWN OF WINDSOR
SETTING RADAR ENFORCEABLE SPEED LIMITS FOR TOWN STREETS**

THE TOWN COUNCIL OF THE TOWN OF WINDSOR DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Sections 4-5-710 through 4-5-740 of the Town Code (Ordinance No. 93-43 part) are amended to read as follows:

4-5-710 Twenty-Five (25) Miles Per Hour. The following portions of Town Streets are hereby declared to have a prima facie speed limit of twenty-five (25) miles per hour:

4-4-715 Thirty (30) Miles Per Hour. The following portions of Town Streets are hereby declared to have a prima facie speed limit of thirty (30) miles per hour:

| <u>Name of Street</u> | <u>Location</u> |
|-----------------------|--|
| Windsor River Road | From Windsor Road to Old Redwood Highway |
| Mitchell Lane | Windsor Road to 8 th Hole drive |
| Mitchell Lane | NWPRR to Conde Lane |

4-5-720 Thirty-Five (35) Miles Per Hour. The following portions of Town Streets are hereby declared to have a prima facie speed limit of thirty-five (35) miles per hour:

| Arata Lane | From Troon Court to Foothill Drive |
| Brooks Road South | From Lakewood Drive to Arata Lane |
| Conde Lane | From Oakfield Lane to Old Redwood Highway |

| Hembree Lane | From Shiloh Road to Victory Lane |
| Old Redwood Highway | From Lakewood Drive to Windsor Road |
| Old Redwood Highway | From Hembree Lane to Lakewood Drive |
| Reiman Lane | From Starr Road to Windsor Road |
| Starr Road | From Windsor River Road to Old Redwood Highway |
| Starr Road | From Reiman Lane to Windsor River Road |
| Vinecrest Road | From Hembree Lane to Vinecrest Circle |
| Windsor River Road | From Starr Road to Windsor Road |
| Windsor Road | From Reiman Lane to Windsor River Road |

4-5-725 Forty (40) Miles Per Hour. The following portions of Town Streets are hereby declared to have a prima facie speed limit of forty (40) miles per hour:

| Conde Lane | From Shiloh Road to Mitchell Lane |
| Conde Lane | From Mitchell Lane to Oakfield Lane |

| Hembree Lane | From Victory Lane to Wilson Lane |
| Los Amigos Road | Cordellia Lane to Arata Lane |
| Old Redwood Highway | From Windsor Road to US 101 South Ramps (Arata Interchange) |
| Old Redwood Highway | From Shiloh Road to Hembree Lane |
| Pleasant Avenue | From Old Redwood Highway to Town Limit |
| Shiloh Road | From Skylane Boulevard to Old Redwood Highway |
| Skylane Boulevard | From Town Limit to Shiloh Road |
| Windsor River Road | From Town Limit to Starr Road |
| Windsor Road | From Town Limit to Reiman Lane |

4-5-730 Forty-Five (45) Miles Per Hour. The following portions of Town Streets are hereby declared to have a prima facie speed limit of forty-five (45) miles per hour:

| <u>Name of Street</u> | <u>Location</u> |
|-----------------------|--|
| Los Amigos Road | From Windsor Creek to Cordellia Lane |
| Old Redwood Highway | From US 101 South Ramps (Arata Interchange) to northerly Town Limits |
| Shiloh Road | From Windsor Road to Skylane Boulevard |
| Shiloh Road | From Old Redwood Highway to Town Limit |

4-5-735 Fifty (50) Miles Per Hour. The following portions of Town Streets are hereby declared to have a prima facie speed limit of fifty (50) miles per hour:

| <u>Name of Street</u> | <u>Location</u> |
|-----------------------|-----------------|

4-5-740 Fifty-Five (55) Miles Per Hour. The following portions of Town Streets are hereby declared to have a prima facie speed limit of fifty-five (55) miles per hour:

SECTION 2. This Ordinance shall take affect and be in force thirty (30) days from and after the date of its passage. The Town Clerk shall cause this Ordinance to be published or be posted in at least three (3) public places in Town in accordance with Section 36933 of the Government Code of the State of California.
